### From COP6 to COP7: Rising **Misinformation on Tobacco Farming** Issues

COP6 agenda key points

Articles 9&10 Regulations of Content and Emission

### **COP6** revisited progress on:

- Testing and measuring cigarette contents/emissions
- Disclosure of product information by manufacturers
- Possible future global standards on ingredients

Disagreements persisted over feasibility and scientific bases for uniform standards.

What Leaf-Content Regulation Would Mean for a Tobacco Grower:

- → Loss of viable varieties
- → Higher production costs
- → Reduced market access
- → Threats to livelihoods and national economies

As the anti-tobacco narrative intensified, a growing set of claims about the socio-environmental and economic harms of tobacco growing began circulating—often without scientific evidence or with generalizations that ignored the realities of tobacco-dependent communities. At this stage, almost anything could be asserted about tobacco farming, regardless of data quality or context.

In response, the ITGA launched its "Myth vs Fact" campaign, designed to correct misinformation with evidence-based analysis and the lived experience of growers. The campaign focused on key areas where myths had become especially widespread:

- Viable Alternatives to Tobacco
- Child Labour in Tobacco Growing
- Tobacco Growing and Food Security
- Health and Safety Risks of Tobacco Growing
- Environmental Impact

Through this initiative, ITGA sought to bring balance, scientific grounding, and the growers' perspective back into discussions increasingly dominated by one-sided or inaccurate assertions.









### WHO FCTC 20th Anniversary



During COP6 and COP7, restrictions surrounding COP meetings intensified significantly. What began with the cancellation of all public sessions soon evolved into broader limitations: controlled access to areas around the meeting venues, tighter movement restrictions, and in even the **expulsion** several instances representatives from the COP premises. These measures marked a notable shift toward increased opacity in the COP process and raised growing concerns about transparency, stakeholder access, and the ability of observers to follow negotiations.
